## **COMPETITION RULES AND FORMS**

The aim of the Competition is:

- to promote children and youth whose passion is piano playing at both professional and amateur levels
- promoting piano talents
- international integration of musical milieux

**Category A "**The Piano - my passion" - aimed at students of public and non-public music schools, teaching according to the ministerial core curriculum for music schools.

**Category A1** "The Piano - my hobby" aimed at piano lovers learning in non-public music schools, students of piano as the secondary instrument at music schools, music centres, other music education establishments and those taking individual lessons.

#### STAGES OF THE COMPETITION

Stage I - online preliminaries - submissions by 1 May 2024

Stage II - finals and winners concert in the ballroom of the Museum of Interiors of the National Museum in the Palace in Otwock Wielki on **15** June **2024**.

## **DIVISION INTO GROUPS, REPERTOIRE REQUIREMENTS**

## Category A - "The Piano - my passion"

- 1. A polyphonic or polyphonising piece from the Baroque period.
- 2. A piece of cantilena character.
- 3. One study or piece of virtuoso character

Suggested piece by I. J. Paderewski or another Polish composer. **Pieces are performed from memory.** 

## Category A1 - "The Piano - my hobby"

Two contrasting pieces from the classical music canon in original arrangements. Suggested piece by a Polish composer.

Works of film and pop music in original arrangements are allowed. Facilitated arrangements of classical pieces are excluded. **Pieces are performed from memory.**

#### **ENROLMENT OF PARTICIPANTS**

1. Participants are registered via an electronic form together with a link to the audio-video recording and proof of payment at the competition website <a href="https://www.szkola-muzyczna.com">www.szkola-muzyczna.com</a> by 1 May 2024.

The list of finalists will be published by 1 June 2024.

2. The recordings must be uploaded to a single file on YouTube and marked as a non-public video (but not as a private video). In the title please include the name of the participant and the category and class, and in the description of the video give the full name of the competition and a detailed programme.

The pieces can be recorded separately (recorded from a static camera) and then merged into one film. Assembly cuts during the course of individual pieces are not permitted. Silhouette of the performer must be visible in its entirety.

- 3. The quality of the recording should allow a fair assessment of the participant's play. HD quality or higher is preferred.

#### JUDGING AND AWARDS

All participants will receive diplomas for their participation in the Competition in electronic form.

Winners diplomas and distinctions will be awarded in each age group. There will be prizes in kind for the winners.

- The distribution of prizes and distinctions will be decided by the Jury. The decisions of the Jury are indisputable.
- The evaluation of the artistic presentations of the participants will be made by a Jury composed of distinguished educators and professors.

The evaluation is determined by the number of points awarded to the participant. A participant can receive a maximum of 25 points.

- for the performance of a I. J. Paderewski's piece
- for the performance of a F. Chopin's piece
- an invitation to take part in the I. J. Paderewski International Festival in Warsaw
- an invitation to take part in concerts organised by, among others, the Fryderyk Chopin Society in Warsaw and the Museum of Interiors of the National Museum in the Palace in Otwock Wielki.
